#### **CRITERIA**

DVD and VHS's presented for a rating need to be accompanied by the LETTER OF ACKNOWLEDGEMENT and STATEMENT OF VALIDITY FORMS authorizing you as the lawful producer/distributor, of the submitted title, who has the lawful right to request a rating from the Film Advisory Board, Inc.

We accept cashier, personal and business checks. If you should require the Film Advisory Board, Inc. to return all submissions please include return postage and the carrier's Express Service account number.

Once you receive the FAB rating, be sure the rating appears in a prominent position on the front or back and spine of the DVD case or the VHS cassette box. If possible, the rating should be placed on DVD and VHS labels.

The rating category with the content description should be printed in bold caps (see example on next page).

Please forward two samples of the label and one complete DVD or VHS that show the Film Advisory Board, Inc. imprint, to our attention. Thank you.

Titles can not be changed without advising FAB. If content changes and new material is added, after our initial rating of the DVD or VHS title, a RE-EVALUATION is required, since the initial rating can not be used when content changes have been made.

### FAB RATING SYSTEM FEES continued

The re-evaluation of DVD or VHS submission assures that the FAB rating of the title is in the correct category. The fee for the re-evaluation is one half (1/2) of the original fee paid.

Print, TV, theatrical trailers, internet and all other advertising of titles rated by Film Advisory Board need to be in accordance with the category that the title was designated.

The Film Advisory Board, Inc. provides the original artwork of the rating category. The producer/distributor will be required to drop in the content description FAB has delineated. (see example below).
